Reminder: Outstanding Rejections and Use of *correctionList*

- ▶ Effective February 26, 2024 in the Production Environment, all Data Validation Errors may be repaired by submitting a *correctionAction* of 'DELETE'.
- ▶ Any FDID Records or Customer Records that are required to be reported to CAIS but were submitted with a *correctionAction* of 'DELETE' must be accepted in their full current state by CAIS in a prior or subsequent submission.
- ▶ Rejections on Customers and Accounts that were not required to be reported to CAIS cannot be removed from the compliance error rate.
 - Industry Members are encouraged to repair these rejections.

Update: Feedback File for FDIDs in Transaction and not in CAIS

The one-time feedback file containing FDIDs accepted in CAT Transaction but not accepted in CAT CAIS that was originally scheduled to be published on February 27, 2024 is delayed and is now expected to be published by 5:00 p.m. ET on February 29, 2024.
